- To receive the \$40 per application payout, you must submit **25 or more** GTL Advantage Plus®, Indemnity Plus® Hospital Indemnity, Precision Care™ Cancer Insurance and/or Short-Term Home Health Care applications during the Fourth Quarter.
- Policies must also be effective, issued and inforce as of January 31, 2021 to qualify.
- Bonus payments will be calculated and distributed no later than March 1, 2021.

Submit 50+ Applications During Q4

Hospital Indemnity, Precision Care™ & **Short-Term Home Health Care Bonus**

per application

For each Advantage Plus®, Indemnity Plus®, Precision Care™ and/or Short-Term Home Health Care application submitted, signed and dated within the qualification period.

- To receive the \$60 per application payout, you must submit **50 or more** GTL Advantage Plus®, Indemnity Plus® Hospital Indemnity, Precision Care™ Cancer Insurance and/or Short-Term Home Health Care applications during the Fourth Quarter.
- Policies must also be effective, issued and inforce as of January 31, 2021 to qualify.
- Bonus payments will be calculated and distributed no later than March 1, 2021.

Business written on self or immediate family members will not count toward qualifying production. Premiums under \$15 monthly EFT or \$180 annually do not count toward qualifying production. Qualifiers must maintain a minimum persistency on qualifying business.
