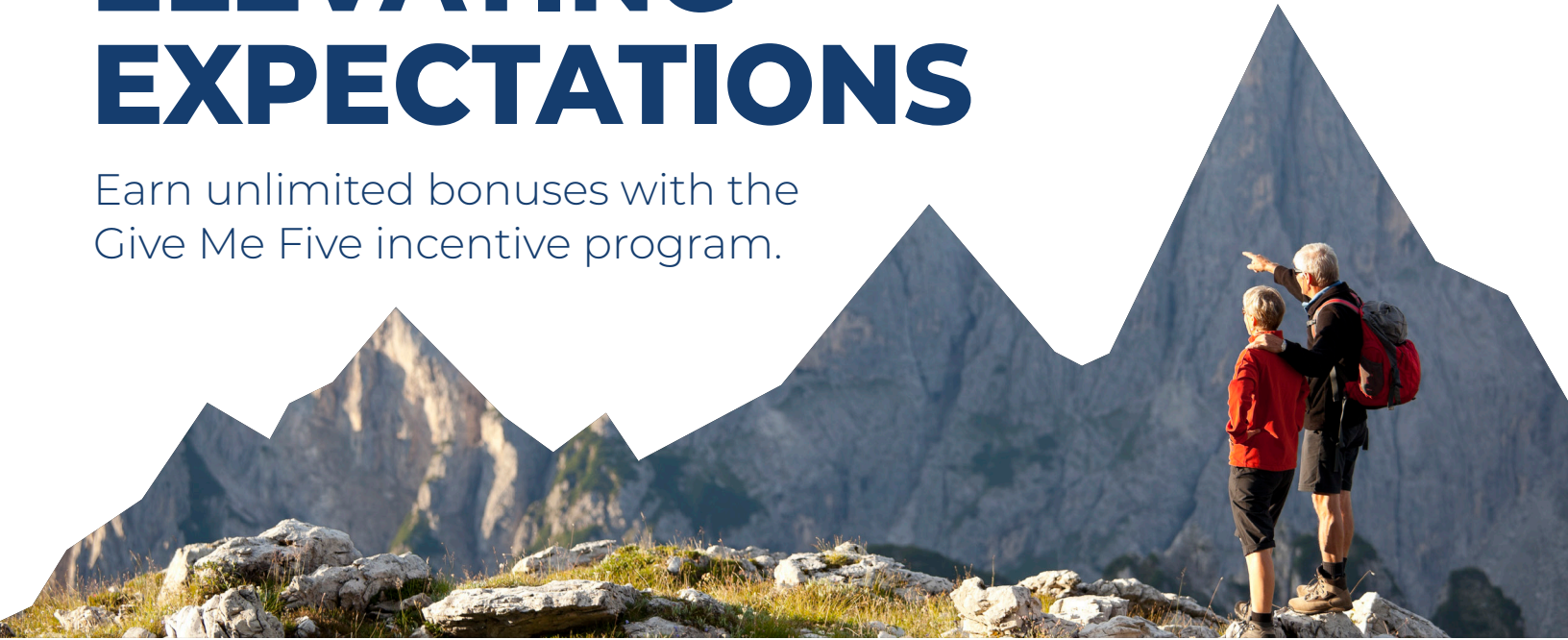

Great Western Insurance Company's Give Me Five incentive program rules:

1. To qualify for the monthly payout, applications must be written on MyEnroller<sup>SM</sup> between June 1, 2022, and Aug. 31, 2022, and "taken" before the monthly payment period. "Taken" means the policy has been issued and a premium has been retained by GWIC. For every five taken applications by Aug. 31, 2022, you earn \$200.
2. Monthly payment periods are on July 15, 2022; Aug. 15, 2022; and Sept. 15, 2022.
3. Qualifying policies include GWIC's Great Assurance®, Graded Benefit, and Guaranteed Assurance Final Expense insurance products.<sup>1</sup>
4. GWIC reserves the right, in its sole discretion, to cancel or change the incentive program rules at any time.
5. Agents must remain in good standing and be actively contracted with GWIC at the time of payout.
6. The value of any award will be reported as income to the awarded recipient in accordance with the rules and regulations of the Internal Revenue Service.
