- Producers must have attained a qualifying production level of the above in paid premiums by Dec. 31, 2022.
- If the producer doesn't qualify based on 2022 production, they have an opportunity to qualify for the program by reaching one of the production levels in paid premiums in 2023.
- If the producer's production exceeds a qualification level, the producer will move to the next tier level and be paid retro basis points to dollar one earned.
- Loyalty Program payments will be paid March, May, July, September, November 2023 and January 2024.
- Payments for qualifying licensed only producers will be paid to the upline.
