Trip Qualification Rules

Qualifying Business: New business Medicare Supplement (American Benefit Life or Capitol Life) or Hospital Indemnity Plus (Liberty Bankers Life) applications must be submitted and approved on or after October 1 and on or before December 31, 2023, and paid by January 5, 2024. Medicare Supplement is for underwritten Plan G or Plan N new business only. For example, you cannot replace existing American Benefit Life or Capitol Life business with a new American Benefit Life or Capitol Life policy. Incentive excludes guaranteed issued and open enrollment.

Prize: Level 1 qualifiers will earn a 2-night weekend getaway to a destination of their choice valued up to \$1,125 inclusive of airfare for the producer and hotel for two nights. Level 2 qualifiers will earn a 3-night weekend getaway to a destination of their choice valued up to \$1,875 inclusive of airfare for the producer and hotel for three nights.
