Nassau insurance policies are issued by Nassau Life Insurance Company of Kansas (herein referred to as the "Company"), a subsidiary of Nassau Financial Group. Product availability varies by location and plan type is subject to change. Only Medicare Supplement policies issued by the Company are eligible for these promotions.

1. Producer must issue at least three underwritten or open enrollment Plan F, G or N applications between 1/1/2024 and 3/31/2024. Producer will earn a \$200 bonus for each Plan F, G, or N underwritten application submitted during this period which results in a policy issued before 4/11/2024 with an effective date no later than 6/1/2024. Only underwritten applications will receive the bonus. Plan A and guaranteed issue enrollments are excluded. Bonuses earned will result in full chargeback if policy does not remain active and inforce for a full 12 month cycle. Producer must be in good standing at the time of bonus payment. Producer is responsible for reporting earned bonuses for tax purposes and will be provided an appropriate 1099.
2. Qualification period runs from Jan. 1, 2024 to Dec. 31, 2024. Placed premium excludes free looks and cancellations. Participants must have an active contract and be in good standing to receive incentives. Final qualification remains at the sole discretion of Nassau. Cases, premium, or credits may not be transferred to another appointed individual/producer. Some event expenses related to you (and your potential guests) that are associated with the Nassau Elite Producer Program may be taxable to you and reported on a 1099-NEC. You should consult your tax advisor if you have questions about the tax treatment related to any event-related expenses or your individual situation.
